## **END SEMESTER EXAMINATION**

The second halfSPPU examination (Oct 2021) was conducted physical mode in month of December and due to the pandemic situation theory examination was conducted online mode in the month of February and March.The end semester examinations of 1 hour duration evaluated out of 60 marks. SPPU kept Links open for 2 hrs in case students suffered any network or login ratio.

The First half SPPU examination (April 2022) was conducted physical mode in month of June and July and theory examination 20 June to 26 July 2022.

For Courses with maximum marks of 13 continuous assessment and end semester examination with maximum marks of 50.

## UG Students can clear backlogs if any,

In any semester. To be awarded I / II division for an undergraduate examination a student is required to pass all papers within the stipulated 6 semesters. The year and month of passing for the exam is indicated in the consolidated memo of marks. Students who fail to clear all the subjects will be considered as supplementary candidates. No division will be awarded.

For PG the end semester examinations of 2 hours duration, evaluated out of 60 marks will be in the form of a MCQ pattern. External experts set the question papers and University evaluate the answer scripts. PG supplementary Examinations will be conducted only in the Even Semester.

#### **Declaration of Results**

- There is no minimum passing marks for internal Assessment test. The minimum mark for passing in a subject is 50% in the End Semester and 50% of marks in the aggregate of the Internal Assessment and the End Semester. Those who secure less than the stipulated minimum will be declared failed.
  - If a student passes the end semester examination but fails to get the adequate aggregate of the Internal Assessment and the End Semester she should repeat the End Semester Examination.
  - The minimum mark for passing in a subject in PG is 50% in the End Semester and 50% of marks in the aggregate of the Internal Assessment and the End Semester. The college has implemented Grading System for PG and UG.
  - There is no provision for an Improvement Examination.


