

- The appointment is based on certain assumptions and subject to the respective provisions of the Maharashtra Public Universities Act 2016 and Statutes/Ordinances, Rules and Regulations framed thereunder.
- It shall be obligatory on every faculty member of affiliated colleges to render necessary assistance and service in respect of examinations of the University.
- As per the decision taken by the statutory bodies, the mode of examinations will be online consist of 60 multiple choice questions of one mark each for examinees. Out of these 50 correctly solved questions will be considered for the evaluation purpose. As per the decision taken during the meeting of Board of Examinations & Evaluation for under-graduate and post-graduate programs in Statistics and Mathematics under all faculties, there will be 30 multiple choice questions of two marks each. Out of these 25 correctly solved questions will be considered for the evaluation purpose.
- Kindly note that the paper-Setters/Examiners/Moderators/Supervisors whose following relatives are appearing in a subject,
 - at under -graduate examination are not eligible for appointment as a Paper-Setter/Examiners/Moderators/Supervisors at under graduate examinations only of that specific faculty .
 - at post-graduate examination are not eligible for appointment as a Paper-Setters/Examiners/Moderators/Supervisors at post-graduate examinations only of that specific faculty.
- "Father, mother, wife, husband, Son, daughter, daughter in law, brother, sister, first cousin and their children.**
- For all other programs question papers shall be set on 100 percent syllabus.
- Method of uploading question bank:**
 - For the examinations which are proposed to be conducted for the first time at the University level for those subjects taught first time as per the revised syllabus each multiple choice question bank shall have 200 questions. These shall be uploaded through the designated web-portal using BCUD Login of the Chairman of the paper setting panel through the web-portal qpg.unipune.ac.in specially developed for this purpose. It is mandatory to prepare question banks in prescribed format which is made available to the paper setters on the qpg.unipune.ac.in. Only Chairman of paper setting panel is eligible to upload questions in question bank.
 - For the other cases where the examinations are already conducted using the question bank provided by the paper setting panel, the question bank will be available in excel format . These papers setting panel is required to include additional new 50 questions in the question bank. Precautions shall be taken not to include questions, which already exist in previous question bank.





