2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organizes special Programmes for advanced learners and slow learners

The students admitted to Siddhant College of Pharmacy come from a variety of educational and sociocultural backgrounds. The Directorate of Technical Education of Maharashtra State (DTE) oversees the centralised admissions procedure. Students with a wide range of talents, languages, and professional adaptations are given a few days to adjust to college life before being classified as slow or advanced learners. The approach of identifying slow and advanced learners will neither harm pupils or "label" them. The institute regularly examines students' understanding levels through midsemester, end-semester exams, presentations, viva-voce, assignments, and so on. The Institute has issued clear instructions to all study departments to conduct online assessments differentially for advanced and slow learners. Faculty members recognised advanced learners and organised forums to motivate them for the GPAT Exam, NIPER Exam, value-added courses, competitive exams, Avishkar projects, poster presentations, career advising sessions, research projects, and other activities. Staff provided assignments, bridge

courses, chart-making activities, YouTube links, PowerPoint presentations, and notes to help slow learners understand the idea. Advanced and slow learners were always encouraged to become involved in extracurricular and co-curricular activities that would boost their self-esteem and competence.

2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem solving methodologies are used for enhancing learning experiences

Acknowledging the student as the primary beneficiary, the institution organises a variety of events during the semester, including experiential, participatory learning, and problem-solving approaches. Experiential learning activities such as herbarium sheet fabrication, project-based learning, on-the-job training, internships, simulation, YIN participation, sophisticated instrument handling, and so on are undertaken. These strategies help pupils become self-sufficient and independent, promote creativity and imagination, and improve their hands-on research and practical abilities.

Participatory educational endeavours include survey projects, expert series, project presentations, interviews, quiz competitions, social gatherings, model making activities, road safety awareness campaigns, yoga days, tree planting, Har Ghar Tiranga, fire safety awareness, Swacchata Abhiyan, boold donation, rain water harvesting, disaster management, Ek mutthi anaj, industry visits, and so on.

These strategies try to revert learning, bring students to the stage, and encourage learning. Method solving approaches include research projects, seminars on Nirbhay Kanya, women's empowerment, and the protection of female children, advanced technology, question paper-based problem solving, assignments, and so on. These strategies provide ample opportunities for pupils to incorporate and practise troubleshooting methodology.

2.3.2 - Teachers use ICT enabled tools for effective teaching-learning process. Write description in maximum of 200 words

The crew is skilled at conducting ICT-enabled practicals as well as lectures. Students as well as teachers use VMedulife software to teach and learn. All classrooms are equipped with ICT facilities such as Smart Classrooms, LCD Projectors, and so on. The college campus has WiFi access to ensure efficient use of digital technology. Staff employ a variety of internet channels to successfully disseminate wisdom, including YouTube, Zoom videoconferencing, Google Classroom, Google Forms, plagiarism detection software such as Smart SEO tools, and so on. The library has online electronic materials such as PPT presentations, virtual labs, YouTube links, and so on, which students and staff can access through VMedulife. To reduce the number of animals used in research, EX pharm software is used. Both professors and students participated in online courses such as SWAYAM certified. Students can acquire information regarding conversation and the development of soft skills in a fully furnished language lab. Since auditory memory has been shown to be more long-term in pupil retention, teachers also take advantage of the educational CDs that are accessible to help pupils develop their fundamental concepts. By holding workshops, educators are provided with opportunities to improve their instructional abilities.

2.5 - Evaluation Process and Reforms

2.5.1 - Mechanism of internal assessment is transparent and robust in terms of frequency and mode. Write description within 200 words.

An internal assessment is based on sessional assessments, tasks, class tests, class-related activities such as presentations, posters, and model making, projects, and so on. Sessional examinations are held each semester in accordance with the University's program. The notice, timing, question paper format, and syllabus for the exam are posted on the notice board eight days before the exam begins. The question paper is drawn by the responsible employees eight days before the exam. Its purpose is to ensure that the invigilation responsibility throughout the theory sessional is not given to the same topic teacher. Following the internal exam, the papers are examined by the appropriate staff members within 72 hours. After the examination, the subject teacher creates an answer key for the question paper and distributes it to the pupils. He/she discusses the appraised work with each student personally, focussing on areas for development. The subject's marksheet is published on the notice board only after each student has reviewed and approved their results. 2.5.2 - Mechanism to deal with internal examination related grievances is transparent, time-bound and efficient

The instructor in charge assesses the answer papers within a given time frame, which are then shown to students for verification for any discrepancies. The pupils are informed about the marking method and evaluations. If there is any ambiguity, the subject in charge clarifies it, and corrections are made as appropriate. If the student fails to agree with the an explanation, he or she may refer it to the Examination Department, where it will be resolved by senior professors, the HOD, and the Principal. After answering students' questions, the marksheet for internal sessional examinations is shown on the notice board.

The marks of internal sessional exams are certified by students' signatures on sealed registers and reported to the University. The institution provides translucent, timely, and effective examination-related grievance resolution. Except in severe circumstances where the Head of the Institution is required to intervene, the separate heads of Departments are empowered to act and pronounce on any internal and university level examination-related concerns.

including experiential, participatory learning, and problemsolving approaches. Experiential learning activities such as herbarium sheet fabrication, project-based learning, on-the-job training, internships, simulation, YIN participation, sophisticated instrument handling, and so on are undertaken. These strategies help pupils become self-sufficient and independent, promote creativity and imagination, and improve their hands-on research and practical abilities.

Participatory educational endeavours include survey projects, expert series, project presentations, interviews, quiz competitions, social gatherings, model making activities, road safety awareness campaigns, yoga days, tree planting, Har Ghar Tiranga, fire safety awareness, Swacchata Abhiyan, boold donation, rain water harvesting, disaster management, Ek mutthi anaj, industry visits, and so on. The crew is skilled at conducting ICT-enabled practicals as well as lectures. Students as well as teachers use VMedulife software to teach and learn. All classrooms are equipped with ICT facilities such as Smart Classrooms, LCD Projectors, and so on. The college campus has WiFi access to ensure efficient use of digital technology. Staff employ a variety of internet channels to successfully disseminate wisdom, including YouTube, Zoom videoconferencing, Google Classroom, Google Forms, plagiarism detection software such as Smart SEO tools, and so on. The library has online electronic materials such as PPT

presentations, virtual labs, YouTube links, and so on, which students and staff can access through VMedulife. To reduce the number of animals used in research, EX pharm software is used. 2.5 - Evaluation Process and Reforms

2.5.1 - Mechanism of internal assessment is transparent and robust in terms of frequency and mode. Write description within 200 words.

An internal assessment is based on sessional assessments, tasks, class tests, class-related activities such as presentations, posters, and model making, projects, and so on. Sessional examinations are held each semester in accordance with the University's program. The notice, timing, question paper format, and syllabus for the exam are posted on the notice board eight days before the exam begins. The question paper is drawn by the responsible employees eight days before the exam. Its purpose is to ensure that the invigilation responsibility throughout the theory sessional is not given to the same topic teacher. Following the internal exam, the papers are examined by the appropriate staff members within 72 hours. After the examination, the subject teacher creates an answer key for the question paper and distributes it to the pupils. He/she discusses the appraised work with each student personally, focussing on areas for development. The subject's marksheet is published on the notice board only after each student has reviewed and approved their results. If a student misses an evaluation for legitimate reasons, it is possible to retake it.

The instructor in charge assesses the answer papers within a given time frame, which are then shown to students for verification for any discrepancies. The pupils are informed about the marking method and evaluations. If there is any ambiguity, the subject in charge clarifies it, and corrections are made as appropriate. If the student fails to agree with the an explanation, he or she may refer it to the Examination Department, where it will be resolved by senior professors, the HOD, and the Principal. After answering students' questions, the marksheet for internal sessional examinations is shown on the notice board.

The marks of internal sessional exams are certified by students' signatures on sealed registers and reported to the University. The institution provides translucent, timely, and effective examination-related grievance resolution. Except in severe

circumstances where the Head of the Institution is required to intervene, the separate heads of Departments are empowered to act and pronounce on any internal and university level examination-related concerns.

Program-specific outcomes have been created for programs based on pharmacy educational goals and current industrial requirements.
